***New Place Nurseries, London Road, Pulborough, RH20 1AT***

***Reserved Matters application pursuant to Outline Planning Consent DC/21/2321, as varied by application DC/24/1204. The Reserved Matters comprise details of 160 no dwellings, associated internal access roads, parking and landscaping for areas east of the right of way. Details of appearance, landscaping, layout and scale to be considered.***

Further to the submission of information in relation to the above site in 2024, Barratt David Wilson Southern Counties are providing additional information requested by the Council for validation. For the avoidance of doubt we are submitting all information, including that previously submitted, to ensure the Council has all files. *A full list of drawings and revisions is provided at the end of this letter.*

Horsham District Council have indicated that the Reserved Matters Application should be accompanied by a Landscape and Ecological Management Plan. Included within the Planting Schedule & Specification is a preliminary Landscape Management Plan.

Condition 11 of the Outline Planning Permission sets out the requirement for a Landscape and Ecological Management Plan to be submitted to HDC prior to first occupation. BDWSC would prefer to provide the full information pack in line with the stage set out by the condition from the Outline Planning Permission. *A draft pack can be provided for information only if necessary.*
