Comments:

- 1)Barns Green has already had a large number of new houses built in recent years in two developments and this new development is unreasonable in that it will adversely affect the whole rural community here. This village has had its share of new housing.
- 2)Increase in traffic. There is always a line of cars parked outside the shop making two way traffic impossible. A larger volume of traffic would lead to traffic congestion. You cannot stop people parking outside the village shop. It is vital to our community and if people can't park outside it they won't use it.
- 3)Insufficient sewage capacity. Local sewage works would be unable to cope, leading to overflow of raw sewage.
- 4)The main road in the village already floods when there is heavy rain. Water runs down the hill and across the road and the shop has been flooded several times. Where would rainwater go? More houses would make this situation worse.
- 5)Too many cars driving in and out of the village causing noise and air pollution. Due to insufficient bus service most people have to use a car for transport.  
Removal of the hedge would mean water running down off the field onto the road.
- 6)The removal of the hedge which is a sanctity for wildlife also helps maintain the verge, keeping soil and rainwater from the field off the road
