Comments:

Design, Highway Access & Parking: The parking on the roadside around Sergents Way already caused a bottle next at the co-op end down into the development, making this single file most of the day. There is also not adequate visitor parking for the current development, let alone 89 more houses.

Sergeant Way is also not wide enough to allow 2 way traffic on its bends/curves and the bend towards co-op from Tesco has seen multiple RTC's where people speed round and to far out, due to there being no white lining.

Overdevelopment: As stated the development is already over populated with vehicles, adding more houses will only increase the problem.

In addition with this planned development, where will they go for doctors, schools etc. The local is school is small and oversubscribed, doctors who aren't taking on new patients.

Privacy Light & Noise: Additional houses will block light to those houses in the area and increase noise. With more street lighting, more light pollution.

Trees & Landscaping: This area has already changed from a possible school, to neighbourhood centre with tennis courts to housing. Where will the Trees and Landscaping be? No where is the answer!

Other: Sergents Way already has a number of traffic issues since the re-development of the area and the old access being blocked off which I agree with. If you add another 89 houses of traffic, you are increasing the risks of Sergents way traffic becoming even more dangerous.
