

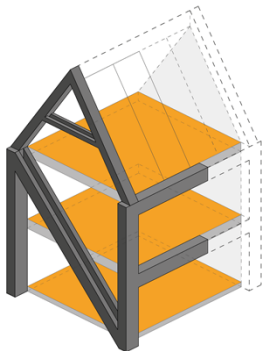

Hope you are well.

Environmental Health at Horsham DC have been consulted on the above planning application which I believe was formally submitted around a month ago.

One of the concerns raised in response to previous applications to convert this building to residential was that the agricultural building immediately to the north (outside of the red boundary line) could be brought back into use and be used for agricultural activities.

When we have spoken about this site before you have informed me that there are restrictions on the above mentioned building limiting what uses can take place, from reviewing our planning system I have however been unable to find any applications with any such restrictions. Its possibly because our online planning database doesn't go back in time far enough but could you or the applicant provide me some further detail on the building to the north, restrictions etc?
