I can only repeat my comments sent to you about this development on 26April 2025</p> <p>Dear Sirs,</p> <p>Urgent Action Required to Prevent Unauthorised Development on Greenfield Land</p>

I am writing to express my growing concern regarding the ongoing issue of unauthorised development on greenfield land within the Horsham District. Despite the existence of planning regulations and Stop Notices, there appears to be insufficient enforcement, allowing breaches to continue or escalate.

I fully acknowledge the importance of providing lawful accommodation options for all communities, including the Traveller community. However, the persistent disregard for planning laws poses a threat to the rural character of our district and undermines public confidence in the planning system.

I respectfully urge the Council to consider the following measures:

1. Swift enforcement of Temporary Stop Notices and full Stop Notices at the earliest signs of unauthorised development.
2. Immediate pursuit of High Court injunctions to pre-empt and halt unlawful activity, especially on known vulnerable greenfield sites.
3. Implementation of Article 4 Directions where appropriate, to remove permitted development rights on sensitive land.
4. Review and strengthening of the Local Plan's Traveller site policies to ensure the Council is not placed at a disadvantage in future enforcement actions.
5. Close cooperation with Sussex Police to ensure public safety and to manage any serious disruption arising from unlawful encampments.

As a resident of this district, I ask that this matter be treated with the urgency and seriousness it deserves. I would be grateful for an update on current enforcement practices and any planned measures to strengthen them.

Thank you for your attention to this matter. I look forward to your response.
