Comments:	Further to my original comments, I would like to raise some additional concerns regarding the proposed development.  1. Road safety It already feels very dangerous exiting from the A24 to Spring Gardens due to the lack of slip road and very sharp turn into where we live. No matter how early you indicate, cars don't register you are turning and definitely don't expect you have to slow right down due to the sharp turn. If this was combined with

extra traffic coming out of what now is a very quiet private driveway I think it would be very problematic.

Furthermore, when we exit where our houses are, we regularly have to contend with cars exiting the A24 very fast (partly due to no slip road, partly due to poor judgement) onto Spring Gardens. It is hard to pull out as you don't see the cars until they are right near you. Again, combine this with increased flow in and out of an extra road and that is troublesome.

## 2. Public Footpath

The current driveway is a public footpath and leads to the route through the woods. How does this work if it is a road?

## 3. Road width.

The drive is narrow, not even close to allowing two cars to pass. The proposed houses are very large and could easily have 4 cars each, plus associated delivery vehicles. This traffic up and down a single track road would not only cause much disruption, but there would need to be a lot of reversing back and forth for passing.
