The application property forms part of a purpose-built age-restricted retirement housing development known as Stanford Orchard which comprises 33no. residential units, communal areas, and associated parking/garaging. The garage subject to this application sits within the coach house block to the east of the site and directly beneath Flat 33. The use of the wider site is for Sheltered / Age Restricted Residential Flats in accordance with the Planning Permission: "WN/57/87- Erection of 33 sheltered residential units consisting of 12x 2 Bed Houses, 12 x 2 bed flats, 8 x 1 bed flats, 1x Warden flat & gardens at Stanfords Builders Yard, Church Street, Warnham". The use of the garage in particular has historically been used for parking and storage ancillary to the residential use of the wider site.
