On behalf of Miller Homes Ltd and Miller M2 (Barns Green) Ltd (hereinafter 'the applicants') I have pleasure in enclosing a full planning application in relation to proposed development at land known as Land at Smugglers' Lane, Barns Green. The proposed description of development is as follows:

Proposed development of 68 dwellings with vehicular and pedestrian accesses, public openspace, hard and soft landscaping and associated works including supporting foul and surface water drainage works, and works to existing culverted watercourse on site

The documents submitted to support the application are based on your validation requirements and confirmation of the required submission documents provided by planning officers in their pre-application response dated 18th July 2025 (see full response at Appendix B of the submitted Planning Statement). A schedule of submitted documents is appended to this letter.

Note that the submitted documents and reports were prepared prior to the recent announcements by the Government¹ and Natural England² in relation to Water Neutrality. The changed guidance means that development no longer needs to demonstrate water neutrality. As a consequence of the updated guidance, the applicants are reviewing the drainage strategy for the site and will submit an updated FRA and drainage strategy in due course.
