Demolition of existing garage. However, off road parking for 3 cars remains on the private driveway and there is unrestricted on road parking available on the public highway of Merryfield Drive. Furthermore, the current garage does not meet the WSCC minimum measurement requirement of 3m x 6m for a garage space.
