Comments:	We, as residents of this household, wish to register our firm objection to the proposed planning application. It is our considered view that the land in question could be put to significantly better use for the benefit of the wider community-for example, through

the creation of public parks, green spaces, or by enhancing essential local amenities such as dental practices, medical facilities, and schools.

Furthermore, we are deeply concerned that the current proposal represents a material departure from the assurances given during the initial consultation process. It was clearly indicated at that stage that there would be no vehicular access from Carter Drive. However, the most recent plans now demonstrate a clear intention to link the proposed development to Carter Drive via new connecting roads. Many residents, ourselves included, chose to purchase properties on Carter Drive precisely because it is a quiet cul-de-sac with limited traffic flow.

The introduction of through traffic would fundamentally alter the character and safety of the road. Carter Drive presently lacks adequate pedestrian pathways, and residents-including children and the elderly-are often required to walk along the carriageway itself. Even with the current level of traffic, this presents a significant safety concern. An increase in vehicular volume would, in our view, create an unacceptable risk, and it may only be a matter of time before a serious accident occurs involving a pedestrian.

In addition, we are aware of reports suggesting that, as part of a traffic-calming initiative, the Council is considering closing the junction between Broadbridge Way and Sargent Way. Should that closure proceed, the inevitable consequence would be to divert traffic elsewhere-most likely through Carter Drive. If the proposed development is granted access to Carter Drive, it would in effect become a rat run through the estate, compounding existing safety and congestion problems rather than alleviating them.

For these reasons, we respectfully urge the Council to reject the application in its current form and to consider alternative proposals that would better serve the long-term interests of the community.
