Please note that following receipt of Natural England's position statement on developments in the Sussex North Water Supply Zone, decisions on planning applications should await the completion of a Sussex North water neutrality strategy.

Summary

We have reviewed the decision notice for DC/21/2180 and note that the following conditions relate to ecology and require submission of the relevant documents:



- Condition 4: a Construction Environmental Management Plan – Biodiversity.
- Condition 8: a Hazel Dormouse mitigation licence
- Condition 9: a Biodiversity Enhancement Strategy
- Condition 10: a lighting scheme for biodiversity

In addition, Condition 15 is a regulatory condition securing the mitigation and enhancement measures in the Ecological Impact Assessment (September 2021).

We understand that Conditions 4, 9 and 10 are under consultation as discharge of condition application numbers DISC/25/0325, DISC/25/0321 and DISC/25/0322 respectively.

We note that the Construction Ecological Management Plan Version Vf1 (Ecology Solutions, October 2025) has been submitted and would support this document in the discharge of Condition 4.

We also note that the Biodiversity Enhancement Strategy Version Vf1 (Ecology Solutions, September 2025) has been submitted and would support this document in the discharge of Condition 9.

We understand that the Hazel Dormouse mitigation licence has not yet been submitted in respect of Condition 8.

We note that the Outdoor Lighting Report (MMA Lighting Consultancy Ltd., October 2025) has been submitted. However, we recommend that a lighting scheme for biodiversity is submitted with respect to Condition 10 and highlight that a Habitats Regulations Assessment (HRA) Appropriate Assessment for submission to Natural England by the LPA cannot be prepared until this has been submitted.

We look forward to reviewing the Hazel Dormouse mitigation licence and a lighting scheme for biodiversity when they become available.
