Details of the pre-application advice received

Formal pre-application advice was received from Horsham District Council.

The Council acknowledged improvements in design quality and layout compared to the earlier refused scheme (DC/22/1960), and accepted the principle of residential development on the site.

The advice recommended reducing the building footprint and increasing opportunities for landscaping to help address concerns about overdevelopment and the setting of the adjacent non-designated heritage asset (Flagstones). The revised scheme has incorporated both of these changes.

The Council also noted that the proposed rear projection could result in harm to the amenity of Flagstones. This has been addressed by introducing a more sensitive rear building line, stepping the building's height, and including floorplans of Flagstones to demonstrate the relationship.

All recommendations received have been considered and addressed in the revised proposal submitted.
