Details of the pre-application advice received

In principle, whilst there is no objection to the principle of development, it would be considered that the proposal would currently not respond from a design and amenity perspective and would not meet the requirements of Policies 32 and 33 of the HDPF (2015). However, it is recognised that the proposal does not need total revision and likely could be made acceptable via revisions to the scale and massing of the property to tie in more appropriately to the locale. In addition, it would be of benefit to revise the hardstanding for planting to give a softer appearance and help create a more lush street-scape to combat the loss of greenery. Additional plans such as landscaping and streetscape plans would be of benefit to submit.
