

Dear Jason Hawkes,

I write in my professional capacity as a **Member of the Chartered Institute of Personnel and Development (MCIPD)** to set out, in concise form, what I consider to be the **seven principal human implications** arising from the West of Ifield planning application and the associated closure of Ifield Golf Club.

Planning decisions of this scale do not affect land alone. They have direct and lasting consequences for people, organisations, and community confidence, all of which are relevant to the integrity and sustainability of decision-making.

## **1. Psychological security**

The premature closure of a long-established community asset generates uncertainty, anxiety, and a loss of stability among members, staff, volunteers, and residents. Such effects are well recognised in people-management and organisational change contexts.

## **2. Suppression of voice**

The use of Non-Disclosure Agreements affecting Golf Club officers and staff has the effect of silencing those with direct knowledge. Decisions made under conditions of enforced silence carry heightened risk of mistrust and grievance and undermine transparency.

## **3. Erosion of institutional trust**

Where outcomes appear pre-determined before lawful planning determination, confidence in institutions — including the planning authority and the planning system itself — is

weakened. Once lost, trust is difficult to restore.

## **4. Impact on community identity**

Community assets are not interchangeable facilities; they form part of local identity and social capital. Their removal without a clear democratic mandate damages belonging and cohesion, particularly in long-established parishes.

## **5. Precedent anxiety**

Closure of one community asset by a public landlord without transparent justification creates anxiety across other cultural, sporting, and voluntary

organisations, which begin to question the security of their own future.

## **6. Organisational wellbeing and morale**

Abrupt closure undermines morale, dignity, and professional wellbeing for those involved.

From a people-centred perspective, this conflicts with principles of responsible stewardship, fair process, and respect for people affected by change.

## **7. Long-term reputational consequences**

Decisions perceived as procedurally unfair may achieve

short-term objectives but carry enduring reputational risk for promoters, landowners, and decision-making authorities, complicating future engagement and delivery.

Taken together, these human implications reinforce the importance of **procedural fairness, transparency, and democratic confidence**. They are not peripheral to planning; they go directly to its legitimacy.

While the land may now be owned by **Homes England**, ownership should not override the need for decisions to be demonstrably fair, proportionate,

and trusted by the community affected.

I respectfully submit that these considerations strengthen the case for **pause, deferral, further scrutiny - or withdrawal**, before irreversible steps are taken.
