Thank you for clarifying.

I have marked on the attached snip the best positions for the bin-stores to be placed. (x2 options for each block)

Also attached is our refuse and recycling standards document. This outlines what will be required from the developers.

Each bin-store will need to house an additional 140L bin for food waste, plus each single dwelling will need to accommodate a 23L outside caddie and a 7L indoor caddie.

Thanks for the very quick response and query – happy to answer.

At this stage, the scheme is in outline, so house types and tenures are still up for finalising (usually at the reserved matters stage once an outline application is approved). A quick count of the indicative plan reveals that these three blocks would need to accommodate about 25 flats / units.

Also, need to start planning for the imminent food-waste bins in these sites.
